We had another fun filled rally at Flying Flags Buellton, I gained another few pounds thanks to the great catered food and fabulous restaurant gatherings.

We had nine (9) rigs in attendance even though we still have a membership number of twenty-four (24). Some members have recently sold their motorhomes, others had health issues and some were on vacation. Our membership will no doubt be reduced when the time comes to collect dues this coming January unless we get new members.

We are currently a chartered chapter of the FMCA. Our elected officers include a National Director who votes in the FMCA affairs. In order to continue this status, we are required to maintain a minimum of fifteen (15) rigs. In the event our membership falls below the minimum, we will then become an "ASSOCIATE CHAPTER" providing we maintain a minimum of seven (7) rigs.

The only difference would be that we would no longer have a national director or associate national director and have no vote in the FMCA governing affairs. All other benefits would remain the same. Our board would consist of President, Vice President, Secretary and Treasurer.

I don't anticipate that we will get below the 15 rig minimum in the immediate future but we must maintain a minimum of 7 rigs in order to maintain the FMCA benefits afforded to our club. I think the ideal number of rigs for a rally is between 10 and 15. Most R. V. resorts provide a significant discounted site fee for 10 plus rigs. Some resorts like Pechanga require a minimum of 5 rigs for the discount and access to the club house.


