FMCA NATIONAL DIRECTORS REPORT

I attended the FMCA's 90th Family Reunion and motorhome showcase in Redmond, Oregon on August 13 - 16, 2014. There were just under 1500 coaches in attendance. The Governing Board Meeting was very interesting and informative with over 400 voting members from chartered motorhome clubs from throughout the US and Canada.

Membership continues to be an important area of focus for the association. The active count as of January 2013 was 80,475 member families. As of June 2014, the number of active family members was 75,599. Over this period of time, FMCA has recruited 15,282 new members. That number is pretty impressive. The downside of the recruitment scenario is that during the same eighteen month period, 20,463 families were made inactive, for a net loss in membership of 4,776 families. Based upon the numbers provided, FMCA does have a respectable combined renewal rate of 75%. A professional organization has been retained to review and improve the FMCA recruitment program. The FMCA remains financially secure with a budget of over \$7,000,000. Investments yielded a profit of approximately \$1,000,000. this past year.

There were several minor policy changes. Items of discussion included reimbursement of travel cost and council member complaints. Bylaw changes included the one vote per family unit to one vote per adult member

The most significant item of discussion was the recommendation of an association-paid FMCAssist medical evacuation program with Seven Corners for a minimum of three years. This item was voted on and passed by a large margin. This benefit costing approximately \$30,000. per year will go into effect October 2014 and should have a positive effect on recruitment.

The FMCAssist medical evacuation program with Seven Corners was formerly available to FMCA members for a cost of \$85. per individual or \$105. per family. There will be no increase in dues for this benefit which will be fully funded in the current FMCA budget. This benefit will offset current yearly renewal dues of \$40.00.

A motion was made by Marsha Swanson and seconded by Joan Edman to only pay the camp site fees for the Trail Bosses (4 nights) and Assistant Trail Bosses (3 nights) beginning January 2015. Motion passed.

BENEFITS INCLUDED IN FMCA DUES

FMCAssist coverage is available to members free of charge as long as you are more than 100 miles from home. You can be traveling in a motorhome, car, plane, ship or motorcycle to be eligible for this benefit. This coverage is provided by Seven Corners and is underwritten by Lloyd's of London. What you need to do to enroll in this program? Absolutely nothing! As long as you continue to keep your FMCA dues current.

EMERGENCY MEDICAL EVACUATION/REPATRIATION - The plan will pay covered expenses incurred if any covered injury or illness that commences during the period of coverage results in the medically necessary emergency medical evacuation or repatriation (i.e., the member's medical condition warrants immediate transportation from the medical facility where he or she is located to the nearest medical facility that is capable of furnishing the required level and type of care for the applicable illness or injury as determined by the attending physical in consultation with the Seven Corners medical director). The maximum amount of this benefit is \$500,000.

EMERGENCY MEDICAL REUNION - When emergency medical evacuation or repatriation is ordered and the attending physician recommends that a family member travel with the member, Seven Corners will provide transportation for one individual of the member's choice to be at their side while they are hospitalized and then accompany them during their return to their permanent primary residence. Costs incurred for transportation and lodging are covered by the insurance policy. Approval and coordination of this benefit must be provided by the Seven Corners medical director in consultation with the attending physician to be considered a covered expense. The maximum amount of this benefit is \$50,000.

RETURN OF DEPENDENTS - Should the member be traveling alone with dependent(s) and the dependent(s) is left unattended, the plan will arrange a pay for one-way economy fare to the one location stipulated by the dependent's legal guardian. The maximum amount of this benefit is \$50,000.

VEHICLE RETURN (LIMITED TO TRIPS IN NORTH AMERICA ONLY) - Should the member, due to medical condition, be unable to drive his/her vehicle back to his/her permanent primary residence within the United States, Mexico, or Canada, Seven Corners will arrange and pay to have a designated service return the vehicle to the member's home, provided: a) The member has been transported under either the "emergency medical evacuation/repatriation" or "return or mortal remains" benefits; and b) no one in the member's traveling party is capable of driving, or proficient and competent to drive, the member's vehicle. The vehicle must be in good condition and capable of being safely driven on the highway in compliance with local laws. The insurance plan will also cover the return of any additional vehicle that is legally hitched to their vehicle at the time of the "emergency medical evacuation/repatriation" or "return of mortal remains" to the destination of the pulling vehicle. The member will be responsible for any costs incurred during the return of the vehicle to maintain the safe operation of the vehicle. Alternatively, the member may choose to have his or her vehicle returned by a friend or family member. In such instance, and provided the return has been approved by Seven Corners and the vehicle is returned directly and expediently to the member's permanent primary resident within the United States, Mexico, or Canada, Seven Corners will arrange and pay for transportation of that person to the location of the vehicle, and will also reimburse the member for gas and tolls during the return. In addition, the plan will provide a \$100, per day benefit, up to a maximum of five days for incidental expenses while driving. In no event shall the total expense of a vehicle return exceed \$5,000. for all expenses associated with the vehicle return. If the member chooses to have a friend or family member perform the vehicle return, Seven Corners will no pay more than what it would have cost to have the company arrange the vehicle return. The maximum amount of this benefit is \$5,000.

PET RETURN - Should the member be traveling with his or her pet and become unable to care for it due to a medical emergency, Seven Corners will arrange for the return of the insured's pet to his/her domicile. The maximum amount of this benefit is \$1,000.
